Parking Lot Attendant (16+)

Job Functions:

- Safely operate the tram shuttle transporting guests to their destination

- Control traffic as needed in tram areas
- Provide a safe and friendly atmosphere to guests and team members
- Perform other functions related to traffic and trams as assigned such as crowd control
